 - Guideline "Trading Parameters"

The Membertest stage for SMR16 began on schedule on 12 January 2026 and was introduced in the Membertest environment. Since then, all participants have been able to test all business-relevant processes, functionalities and applications.

Production Rollout

The introduction of SMR16 into the Production environment is planned for 2 March 2026. The rollout will be confirmed by 23 February 2026 with a SIX Swiss Exchange message.
